Which said George Kenwick being present in Court in his own proper person
humbly prayed the favour of the Lord of this Mannor and of this Court to be
admitted Tenant to the premises so surrendered to him as aforesaid that is to say

To four several Indosures lying together in North
Walsham between the Kings highway called Marshgate
Lane on the West and the Common Pasture of North
Walsham to the East and abuts on the lands of John
Withers in part of Francis Bullen in part and the
Lands formerly of Gwenn Hudson and now of John
Gunn in part to the South and the lands of Thomas
Cooper Reg to the North containing together 16 acres
be the same more or less except 2 rods thereof
hereunto sold to John Gunn And also 2 acres

of Marsh and several tyng in Marshgate with
their and every of their appurtenances

To hold to him the said George Kenwick & his assigns & successors so long
as he and they shall continue and be Curates of the said Parish of
Ashmuntall otherwise Ashmenthall of the Lord of this Mannor at
the Will of the Lord according to the custom of this Mannor by the
Rent and Services therefore due and of Right accustomed saving every
ones Right and so forth and he gave to the Lord for a Fine & so forth
and he is there admitted Tenant and his fealty is respited.
