- 1. NWTC CCTV Policy
- 2. NWTC Privacy Impact Assessment for all CCTV usage, since 2015
- 3. Place & description of all warning notices for NWTC CCTV usage and operation
- 4. NWTC Privacy Notice which includes surveillance data captured with CCTV
- 5. NWTC Data retention, data destruction Policy, specific to CCTV surveillance data
- 6. NWTC Registration evidence details with the ICO regarding CCTV management since 2015
- 7. Confirmation of the NWTC evidence that the installation, usage & management of CCTV throughout North Walsham is justified, proportionate, has a lawful basis and necessary.
- 8. Confirmation of the clear basis for the processing of CCTV personal information
- 9. Confirmation of how the live images at the NWTC offices are physically restricted to authorised personnel only, and confirm who is the authorised
- 10. Confirmation as to when the system was installed and for how long it has been in operation

Confirmation that this system at NWTC is still in operation

- 2. The previous Town Clerk did not action this or any thereafter so there is nothing available.
- 3. We are waiting for Secure Defence to supply these and I am liaising with them. Once installed they will be apparent for all to see and will be compliant.
- 4. This is covered by the Policy of Secure Defence and data is stored on a secure unit.
- 5. The data is not held any longer than the HDD site has capacity for.
- 6. NWTC has always been ICO registered which covers CCTV since installation.
- 7. The evidence which has been provided by CCTV has been fully justified as it assisted in resolving several crimes (confidential), is maintained by Secure Defence and offers security to residents/visitors.
- 8. The Police process any confidential information (committed to media) they require by their own legal method and held by the Police/Insurance Co as long as their GDPR Policies state.
- 9. The system is strictly limited to the Police, Secure Defence (the contractor) and
- 10. 2014 and 2014
- 11. Yes all cameras are working.

Please be assured that North Walsham Town Council is complying with legalities pertaining to the CCTV with the exception of signage.
